

Register Now for WPS PY2020 MedicareRx Certification

Get ready to market and sell one of the nation's top-rated Medicare Part D plans, offered by WPS! Certification is required for enrolling and marketing **PY2020 WPS MedicareRx Plan (PDP)** as well as to receive renewal commissions.

The Centers for Medicare & Medicaid Services (CMS) requires training and testing for all agents and brokers prior to selling Part D plans. This helps ensure that agents understand the products they're marketing and their clients receive the information they need to make informed purchase decisions.

WPS offers Medicare RX plan certification training in TWO WAYS:

On-site

Each three-hour training class covers our MedicareRx Plan offering for PY2020 and qualifies for three continuing education (CE) credits.

Online

If you're unable to attend an on-site session **our webinar will be available online in early September**, so you may view the course at your convenience. Online training is not a CE course and does not qualify for CE credit. The online class lasts approximately 90 minutes.

Testing

Following your training, you will access the online-only test via our training portal. You must pass the test in order to complete the required CMS certification. Completion of the training and passing the test with a score of 85% or higher will allow you, a WPS-listed and Wisconsin-licensed agent, to market our PY2020 *WPS MedicareRx Plan*. You will also continue to receive commission for your current PDP clients.

Click **“Returning Student” and log in**. If you don’t remember your password, click **“recover password”** and you’ll automatically receive an email with your password.

PY2020 WPS MedicareRx On-Site Training Registration – 3 CE credits: Go to the ***Curricula tab*** to access the on-site CE training sessions. You will then need to click on the ***register*** link to register for your desired location/session.

PY2020 WPS MedicareRx Online Training Registration: Go to the ***Training*** tab to access the online training and certification and click **“begin course”**. **Please note, online training and certification will NOT be available on or after Thursday, September 5, 2019.** The test will immediately begin once the training course is completed.

New to our WPS Training Portal? Once you access the portal, click on the Register (new student) option. You will need your NPN to complete this step. Once you have completed the registration you will receive an email regarding your account. Please note, at this point you have only registered for an account. Once registered you will receive an auto generated email confirming you have created an account. Regardless of what the confirmation email indicates you are not registered for in-person or online training.

Click on the URL provided in the confirmation email and use the credentials provided to log in (as a returning student) to the portal. Once logged into your account the profile page will appear. No updates are needed on your profile page at this time. Please click on the **“Home”** option in the upper right-hand corner. You are now ready to register for in-person or online training and certification.

The **Centers for Medicare and Medicaid Services (CMS)** requires specific Compliance and Fraud, Waste and Abuse Training as part of the PY2020 PDP certification process. We have built this training into our PY2020 *WPS MedicareRX Plan training* session so **you will not be required to do separate training or submit AHIP certification for our program.**
