NOT REGISTERED IN MIRAMAR-AGENT?

1. Go to Miramar-Agent.com
2. Click Register as an Agent on the log in page
3. Enter and confirm SSN
4. Enter registration code
 - **N/A** (Exchange Program)
 - **JSA2357MA** (Medicare Program)
5. Enter demographic information
6. CHRISTUS 2022 Certification program will display on the Dashboard under ACTIVE PROGRAMS

Important Note: By using the above unique registration code, agents are automatically assigning their commissions to **JACK SCHROEDER & ASSOCIATES LLC** and will be auto enrolled into the certification program.

AGENT RELEASE POLICY

An Agent wishing to move to a CHRISTUS contracted AGENCY from another CHRISTUS contracted AGENCY must present to CHRISTUS a release letter from the current AGENCY. If the current AGENCY refuses to release the Agent, CHRISTUS will honor the refusal for a period of one (1) year from the Agent's request to change. At the end of the one-year period, CHRISTUS will process the change without a release letter, only during annual contracting periods effective January 1st. Agent moves are only processed by CHRISTUS during the contracting period and are effective January 1st of the following year. When an Agent moves from one CHRISTUS contracted AGENCY to another CHRISTUS contracted AGENCY, the Agent's book of business, including commissions, will follow the Agent. Any administrative fees due as described in Exhibit A will be paid solely to the new AGENCY.
