2024 Certification Job Aid

What are the minimum system requirements to use SAP Workflow?

- An internet connection
- Web browser:
 - Firefox v 2+
 - Safari on Mac v 1.2+
 - Google Chrome
- Javascript and cookies enabled
- While not a requirement, Workflow is best viewed using a minimum screen resolution of 1024X768

Helpful Hint: It is best practice to clear your cookies before starting the certification process.

How to clear your cookies before logging into Workflow:

CHROME

- Go to Settings by clicking the three dots on the URL bar (Far right side)
- Scroll down to Privacy and security
- o Choose Clear browsing data
- Under Basic
 - Time range should be All time
 - Check mark Browsing history, Cookies and other site data, Cached images and files
- Choose Clear data
- Close your Chrome window
- Open a new Chrome window

EDGE

- o Go to Settings by clicking the three dots on the URL bar (Far right side)
- Under Clear browsing data click Choose what to clear
- Mark Browsing history, Cookies and saved website data, Cached data and files, and Tabs I've set aside or recently closed
- Click Clear

FIREFOX

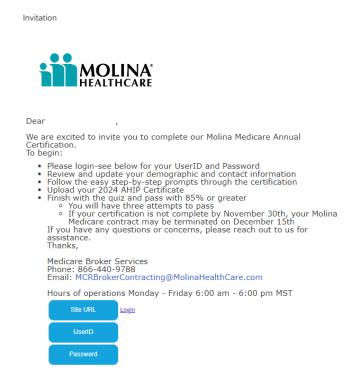
- o Click the menu button and click Library (or click the Library button in the toolbar).
- Click History and then click Clear Recent History...
- o Set Time range to clear: to Everything.
- Select Cookies and make sure that other items you want to keep are not selected.
- Click Clear Now to clear all cookies and close the Clear All History window.

SAFARI

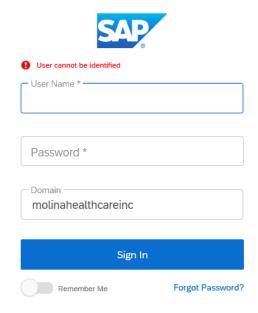
- o Click on Safari (top left corner of browser) in the menu bar. Click on Preferences.
- Select the Privacy tab.
- Click on Manage Website Data

- Select Remove All and click on Remove now in the popup.
- Check in Advanced tab if Show Develop menu in menu bar is selected. If not, Check the box.
- Select Develop in the menu bar on the top of the screen and click Empty Caches to clear Cache.

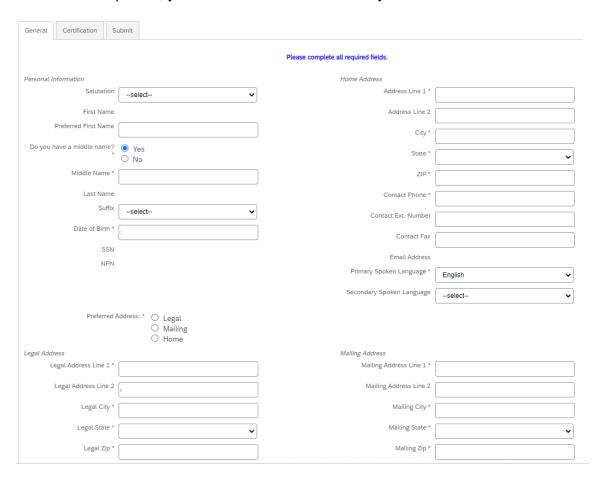
The agent will receive an email invitation from Molina to begin their certification –



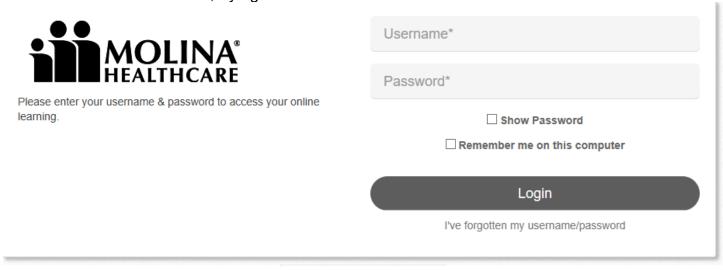
Log into Workflow/Onboarding with credentials provided in email. If password shows 'Please use your previous password to login', and you do not remember your password, use the Forgot Password at the bottom of the login screen. Domain will always be "molinahealthcareinc".



Verify and update your demographics on the general tab. Some fields will be prepopulated. If any field with an * is not completed, you will not be able to submit your certification.



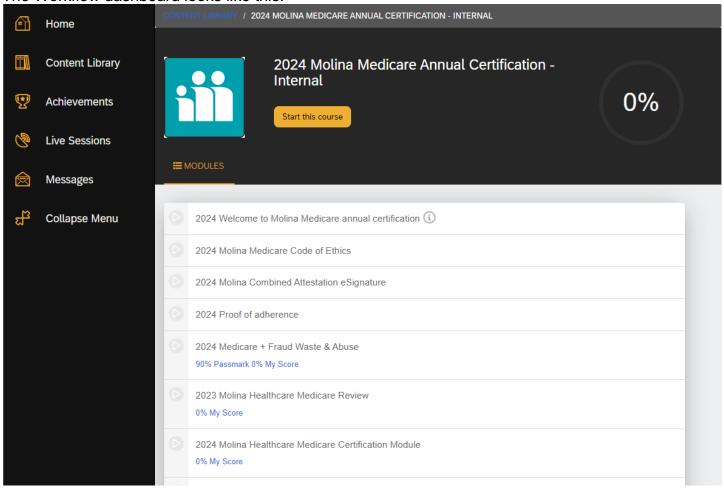
If the agent gets the sign on screen, the agent will need to click on the General tab in Workflow, then the Certification tab. Never click the Next button at the bottom. This will reset the Workflow modules. If it doesn't work the first time, try again.

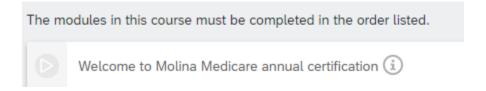
The Workflow dashboard looks like this:

The next module is the Code of Ethics & Fraud Waste and Abuse section. The agent will read the page then click on the > on the right side of the screen five times.

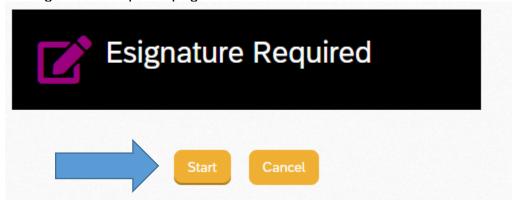


Do not use the NEXT button on the bar.

The next page is Esignature Required page. Push START.



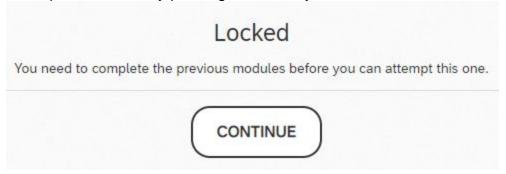
The agent will type their name and check the box to accept. The click SAVE.

The agent needs to click on EXIT. CONTINUE AND PREVIOUS do not work.

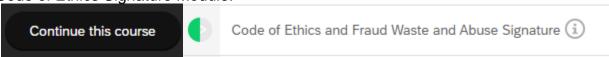


This will bring the agent back to the dashboard. They can click on Continue this course at the top, or on the 2024 Proof of Adherence.

This will bring the agent back to the dashboard. They can click on Continue this course at the top, or on the CMS Approved Medicare + Fraud Waste & Abuse Module



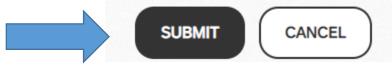
The agent will click on UPLOAD NOW to upload the 2024 approved certificate. The agent can also submit their AHIP through the AHIP website.

Please upload your AHIP Medicare + Fraud Waste & Abuse certificate.

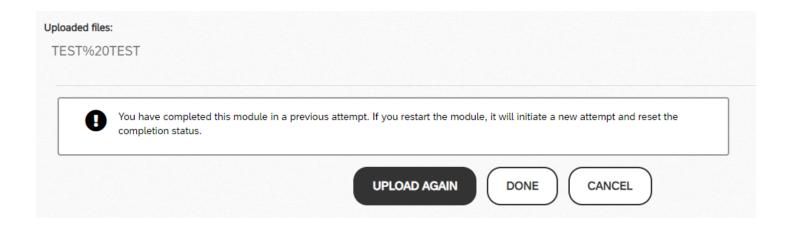

Once the agent has chosen the file. They will push SUBMIT.

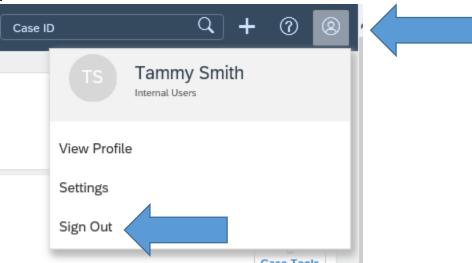


The screen will show the uploaded files. If the agent chose the wrong file, they can UPLOAD AGAIN. If the file is loaded, they will press the DONE button



If the agent gets a **blank screen, or a screen that shows OOPS, the file will not load**, they are NOT IN CHROME. The agent will need to sign out of their workflow by clicking on the person icon

and choosing SIGN OUT.



The agent can then log into Workflow without errors occurring in a CHROME browser.

While in the Workflow Product Training Module, use the prompts at the top of the window in the bar.



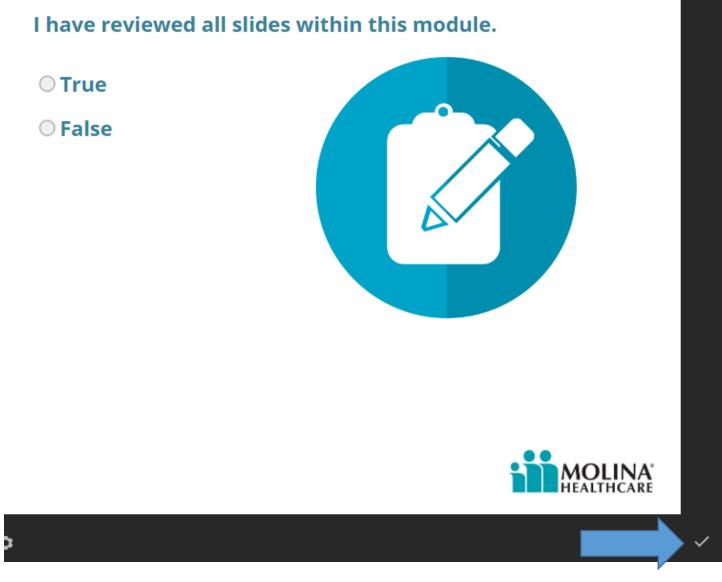
Be sure to turn on the sound so you can hear what each slide is discussing. If needed, you can use the closed captioning within the slide.

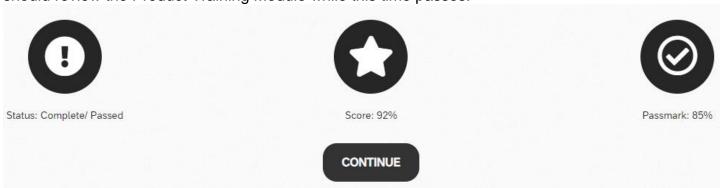
The agent will need to click START to begin the exam.



The agent will have 14 questions to complete. They need to press NEXT QUESTION button at the bottom of the question. It will keep a running total of how many more questions you must answer.



When the agent completes the certification, they will get a screen showing if they passed, their score and what the required score was to pass. If Agent passes, they will press CONTINUE. If not, they can retake the test up to 2 more times. If they still do not pass, they will need to wait 24 hours. The agent should review the Product Training Module while this time passes.



The very last module is 2024 You're not done yet, there is one last step! It directs the agent to submit the certification within Workflow.

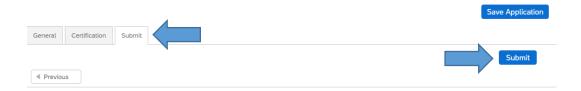

Return to your onboarding case to **submit your certification** to Broker Services to complete your Certification.

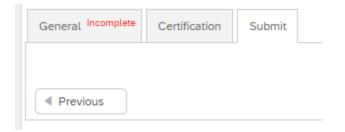
Once submitted, you have now completed your 2024 Molina Annual Certification. Once Molina Broker Services has verified your AHIP you will receive your completion certificate via email within 2 business days.

Certification has been completed. All agents will follow the next steps.

Once the course has been completed, the agent will need to scroll back up to the workflow tabs. Go to the Submit tab and submit your certification or it will not be sent for review.



If any section has not been completed, the corresponding tab will show incomplete.



Go back to that tab and complete the missing fields. You may have to search for what is missing. Look for the * and find which field is empty.

How to update your Internet Browser

Firefox (minimum requirements 2+)

Click the menu button, click Help and select About Firefox. On the menu bar click the Firefox menu and select About Firefox.

The About Mozilla Firefox *About Firefox* window opens. Firefox will check for updates and download them automatically.

When the download is complete, click Restart to update Firefox.

Safari on Mac (minimum requirements 1.2+)

To check for new software, open Software Update. It's in System Settings (or System Preferences), which you can open from the Apple menu in the corner of your screen:

Choose Apple menu > System Settings. Click General on the left side of the System Settings window, then click Software Update on the right.

Or choose Apple menu > System Preferences, then click Software Update.

Once you update your OS, your Safari Browser will also be updated to the newest version.
